RATES & TIMINGS:

General Use Rates	
BROADACRE CROP	Foliar 0.1-0.5 kg/ha Soil applied 0.5-1.5 kg/ha (preplant application).
VEGETABLES	Foliar 0.1-0.5 kg/ha. Soil/Fertigation 0.5-2 kg/ha (best applied in split applications based on soil/tissue testing).
TREES & GRAPEVINES	Foliar 0.1-0.5 kg/ha (note maximum concentrations below). Soil/Fertigation 0.5-1.5 kg/ha (best applied in split applications based on soil/tissue testing).

COMPATIBILITY: Compatible with most common agrochemicals however it is recommended to perform a jar test before mixing. Do not apply with organosilicate adjuvants or copper fungicides by foliar application on all crops.

RESTRICTIONS: Do not apply as a foliar during flowering. Foliar applications on fruit trees do not exceed 0.1% concentration (100g/100L of water). Do not apply as a foliar application to broadacre crops greater than 1% concentration (1kg/100L). If applying with other chelated products do not exceed a maximum concentration as above. Not recommended as a foliar on sensitive crops like stone fruit. Always test on a small scale before spraying the whole crop.

WARNINGS: Keep out of reach of children. Harmful if swallowed. If it comes into contact with skin or eyes, wash immediately with plenty of water. Store in a fresh, dry place and protect from excessive heat. Store the product in its original container. Use the product according to the instructions on the label. If in doubt, please contact your local agronomist or representative. If local experience is unavailable, it is recommended a small scale test application is conducted before widespread use.

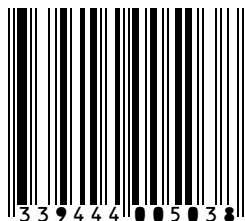
