4 First Aid Measures

Inhalation

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if breathing problems develop.

Skin Contact:

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap for at least 5 minutes. Seek medical attention if symptoms occur.

Eye Contact:

In case of eye contact, hold eyelids open and rinse with water for at least 20 minutes. Seek medical attention if symptoms occur.

Ingestion:

If swallowed, do not induce vomiting. Immediately rinse mouth with water. Never give anything by mouth to an unconscious person. Seek immediate medical attention.

Inhalation: Fatal if inhaled. May cause respiratory irritation.

5 Fire Fighting Measures

Suitable Extinguishing Media: Water fog, foam, dry chemical or carbon dioxide.

Specific Hazards Arising from the Chemical:

Hazardous combustion products include oxides of carbon and nitrogen, other nitrogen compounds, hydrogen cyanide, hydrogen chloride and other chlorine compounds.

Product is not flammable. However, it may form explosive dust clouds in air.

Containers close to fire should be removed only if safe to do so. Use water spray to cool fire exposed containers.

Prevent run-off from fire fighting entering drains or water courses.

6 Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear approved dust/particulate filter respirator and full protective clothing. Evacuate all non-essential personnel from affected area. Do not breathe dust. Ensure adequate ventilation. Avoid generating dust.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and sweep granules into a pile and shovel into drums for subsequent disposal. Avoid generating dust. Consider vacuuming if appropriate. Provide adequate ventilation.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of dust. Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area. Keep container tightly closed when not in use. Protect from heat, sparks, open flames, hot surfaces and direct sunlight. Keep away from strong oxidising agents, strong acids and strong bases.

This is based on the NOAEL of 1.5 mg/kg/day, the level determined to show no effects during long term exposure for the most sensitive indicators and the most sensitive species. (Ref: Australian Pesticides and Veterinary Medicines Authority, 'Acceptable Daily Intakes for Agricultural and Veterinary Chemicals', 2022).
