5 Fire Fighting Measures

Suitable Extinguishing Media: Use fire extinguishing methods suitable to surrounding conditions.

7 Handling and Storage

Precautions for Safe Handling:

Mixing with bases may release irritating ammonia vapour.

May be corrosive to metal. After use wash all metal surfaces with plenty of water.

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Use only outdoors or in a well-ventilated area.

Food, beverages and tobacco products should not be stored or consumed where this material is in use.

Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area. Keep container tightly closed when not in use. Protect from extreme temperatures and direct sunlight. Keep away from bases, sodium hypochlorite and metals.
