### 4 First Aid Measures

**Inhalation:**

If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if breathing problems develop.

**Skin Contact:**

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap. Seek medical attention if symptoms occur.

**Eye Contact:**

In case of eye contact, rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Seek medical attention.

**Ingestion:**

If swallowed, do not induce vomiting. If vomiting occurs spontaneously, keep head below hips to prevent aspiration. Do not give anything by mouth to an unconscious person. Seek immediate medical attention.

**Symptoms Caused by Exposure:**

Skin Contact: May cause slight skin irritation.

Eye Contact: Concentrate will cause severe eye irritation and possible eye damage.

**Conditions for Safe Storage:**

Store in a cool, dry and well ventilated area. Keep in original container tightly closed when not in use. Protect from extremes of temperature and direct sunlight. When wet, corrosive to mild steel, galvanised steel and zinc. Non corrosive to stainless steel, polyethylene and plastics. Do not mix, store or apply the product or spray solutions of the product in galvanised steel or unlined steel (except stainless steel) containers or spray tanks.

### 8 Exposure Controls and Personal Protection

**Exposure Standards:**

The product does not contain any relevant quantities of materials with critical values that have to be monitored at the workplace.
