## DIRECTIONS FOR USE – COMMERCIAL:

**Restrictions:** Eliminate, as far as practicable, all alternative food sources.

DO NOT exceed 3 metres between baits for mice, or 9 metres for rats.

DO NOT place baits in open.

DO NOT apply bait to crops.

## GENERAL INSTRUCTIONS – COMMERCIAL

TITAN Rat & Mouse Killer Wax Blocks are particularly useful in areas where baits deteriorate rapidly, such as damp areas, sub-floors, roof voids and out houses. The hole in the centre of the block will allow pinning or tying in positions off the ground in very moist areas, or where rodents are climbing. The blocks may be used in conjunction with TITAN Mouse & Rat Bait Pellet treatments.

DO NOT place blocks on or near exposed food or food utensils, food preparation areas or food storage areas.

## PROTECTION OF LIVESTOCK, WILDLIFE, FISH, CRUSTACEANS AND ENVIRONMENT

DO NOT contaminate ponds, waterways or drains with chemical or used containers. Place blocks in locations inaccessible to domestic animals, birds and non-target wildlife. The product is hazardous to pigs, cats, dogs and poultry.

DO NOT feed blocks to wild or domestic birds. Collect unused product and carcasses.

## STORAGE AND DISPOSAL

DO NOT use containers which have held bait for any other purposes. Store in original container, in a dry, cool, well ventilated area, out of direct sunlight. Dispose of used containers and unused blocks by burying in an approved landfill. Dispose of all rodent carcasses by burning or burying in an approved landfill. DO NOT destroy packaging while product still remains.

## GENERAL INSTRUCTIONS – HOME GARDEN

**How To Use:** DO NOT place baits out in the open. DO NOT exceed 3m between bait station for mice and 9m for rats. Place baits where there are signs of rodent activity, along walls or rafters and in dark, sheltered places. Use 1 wax block at 1 or more locations for mice and 2 to 4 wax blocks at 1 or 2 locations for rats.

**Baiting Strategy For Effective Control:** Eliminate as far as practical, all alternative food sources. Bait should not be touched as this deters rats and mice from eating it. Bait infested area. Record the number of and location of wax blocks for later replenishment and/or removal. Inspect baits daily. Replace eaten baits. Continue observation and replenishment until no more baits are taken. Ensure baits are removed when rodents activity has ceased. Most deaths occur 4 to 7 days after consumption of bait. Baiting for at least 2 weeks will be necessary to reduce rat/mouse numbers. One feed is sufficient to kill rats and mice. Rats and mice will continue to eat the bait after the lethal dose has been eaten. TITAN Rat & Mouse Killer Wax Blocks will control species resistant to warfarin and bromadiolone. The wax block formulation allows baiting in damp as well as dry locations.

## CAUTION

This product is hazardous to pigs, cats, dogs, poultry, birds and wildlife and care should be exercised in its use. Place baits in locations inaccessible to other animals and birds.

DO NOT allow the product or container to get into drains, sewers, streams or ponds. DO NOT let cats and dogs eat poisoned rats and mice. The use of this product for control of protected native rodents and rodent-like animals requires permission from wildlife authorities.

## STORAGE AND DISPOSAL

Containers which have held bait should not be used for any other purpose. Store in original containers, tightly closed in a cool, dry place out of reach of children.

DO NOT place blocks on or near exposed food or food utensils, food preparation areas or food storage areas.

Dispose of empty container and unused or untaken rat blocks by wrapping in paper, putting in plastic bag and putting in garbage. Dispose of all carcasses by wrapping in paper, placing in a plastic bag and putting in garbage.

DO NOT destroy packaging while product still remains.

## SAFETY DIRECTIONS

Poisonous if swallowed. DO NOT inhale dust. DO NOT touch bait. Use scoop or measure. If on skin and after each baiting wash thoroughly with soap and water. Wash hands after use.

If poisoning occurs, contact a doctor or Poisons Information Centre. Phone Australia 131126, New Zealand 0800 764 766. Vitamin K, (Phytomenadione) is antidotal.
