Hazardous Nature:

Classified as Hazardous according to the Globally Harmonised System of Classification and Labelling of Chemicals (GHS) and Safe Work Australia criteria.

4 First Aid Measures

General Information:

Symptoms of poisoning may even occur after several hours; therefore medical observation for at least 48 hours after the accident.

Inhalation:

If inhaled, remove to fresh air and keep at rest. Avoid all unecessary movement. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Seek medical attention if breathing problems develop.

Skin Contact:

In case of skin contact, immediately remove contaminated clothing and wash affected areas for 10-20 minutes with warm water and non-abrasive soap. Repeat flushing and seek medical attention if symptoms persist.

Eye Contact:

In case of eye contact, rinse cautiously with water for at least 15 minutes while holding eyelid(s) open. Take care not to rinse contaminated water into the unaffected eye or onto the face. Take special care if the exposed person is wearing contact lenses. Continue rinsing. Seek immediate medical attention.

Ingestion:

If swallowed, do NOT induce vomiting. Seek immediate medical attention and show this SDS or the product label.

Symptoms Caused by Exposure:

Inhalation: May cause respiratory irritation. Skin Contact: May cause mild skin irritation.

Eye Contact: Causes eye irritation. May cause redness and lachrymation. Ingestion: May cause gastrointestinal irritation, nausea, vomiting and diarrhoea.

6 Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear protective equipment. Keep unprotected persons away. Do not breathe vapours. Ensure adequate ventilation.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. In the event of a major spillage, create a dike to stop spill from spreading. Collect the spilled material and place into suitable containers for disposal. Decontaminate area with detergent and the smallest volume of water practicable and rinse.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Use only outdoors or in a well-ventilated area.

Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area. Keep in original container, tightly closed when not in use. Protect from direct sunlight, heat, sparks, open flames and hot surfaces. Keep away from strong oxidising agents, strong acids and strong bases.
