Hazardous Nature:

Classified as Dangerous Goods according to the Australian Code for the Transport of Dangerous Goods by Road and Rail (7th edition), IATA and IMDG/IMSBC.

Skin Contact:

In case of skin contact, immediately remove contaminated clothing and wash affected areas with water and soap. Seek medical attention if symptoms occur.

Eye Contact:

In case of eye contact, rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing. Seek medical attention.

Ingestion:

If swallowed, do not induce vomiting. If vomiting occurs spontaneously, keep head below hips to prevent aspiration. Do not give anything by mouth to an unconscious person. Seek immediate medical attention.

Symptoms Caused by Exposure:

Inhalation: May cause respiratory irritation. Skin Contact: May cause slight skin irritation.

5 Fire Fighting Measures

Suitable Extinguishing Media:

Fine water spray or water fog, foam, dry chemical powder or carbon dioxide. Do not use water jet.

Hazardous combustion products include oxides of carbon, nitrogen and phosphorus.

6 Accidental Release Measures

Personal Precautions, Protective Equipment and Emergency Procedures:

Wear approved respiratory protection, chemical resistant gloves, safety glasses, protective clothing and safety boots. Evacuate all non-essential personnel from affected area. Do not breathe vapours. Ensure adequate ventilation.

Environmental Precautions:

In the event of a major spill, prevent spillage from entering drains or water courses.

Methods and Materials for Containment and Cleaning Up:

Stop leak if safe to do so and absorb spill with sand, earth, vermiculite or some other absorbent material. Collect the spilled material and place into a suitable container for disposal.

7 Handling and Storage

Precautions for Safe Handling:

Use of safe work practices are recommended to avoid eye or skin contact and inhalation of vapours. Food, beverages and tobacco products should not be stored or consumed where this material is in use. Always wash hands before smoking, eating, drinking or using the toilet. Wash contaminated clothing and other protective equipment before storage or re-use. Provide eyewash fountains and safety showers in close proximity to points of potential exposure.

Conditions for Safe Storage:

Store in a cool, dry and well ventilated area. Keep in original container tightly closed when not in use. Protect from extremes of temperature and direct sunlight. When wet, corrosive to mild steel, galvanised steel and zinc.

Non corrosive to stainless steel, polyethylene and plastics. Do not mix, store or apply the product or spray solutions of the product in galvanised steel or unlined steel (except stainless steel) containers or spray tanks.
