DIRECTIONS FOR USE

Please confirm boron deficiency by tissue test to finalise rates

Citrus, tropical fruit, nut tree orchards: 100-150 g/100L water 2-3 kg/ha. Generally apply 1-2 times from flowering to fruit set.

Pomefruit, stonefruit: 100-150 g/100L water 1-2 kg/ha.. Generally apply 1-2 times from flowering to fruit set and post-harvest prior to leaf drop.

Cucurbits: 100-150 g/100L water 1-2 kg/ha. Generally apply 1-2 times from flowering to fruit set.

Berry fruits: 1-2 kg/ha. Generally apply 1-2 times from flowering to fruit set

Broadacre (corn, cotton, canola, cereals, soybean): 0.5-2 kg/ha 3-5 kg/ha. Generally apply between early growth to flowering.

Hydroponics: Include in stock solution B tank.

Lucerne/Pasture: 100-150 g/100L water 1-2 kg/ha. Apply as required.

Potato, tomato, capsicum: 100-150 g/100L water 1-2 kg/ha. Generally apply 1-2 times from 10-14 days post-emergence, 4-6 leaf.

Vegetables/Brassica: 100-150 g/100L water 2-3 kg/ha. Apply 2-3 times from 4-6 leaf.

Vines/Grapes: 100-150 g/100L water 1-1.5 kg/ha. Generally apply 1-2 times from pre flowering to fruit set.

ENVIRONMENTAL CARE and STORAGE

Always store out of direct sunlight in a cool place.

Environmental Care: Do not allow product to contaminate drains or watercourses. Avoid using excess rates that may lead to applied nutrients leaching into underground water systems. Dispose of empty bags responsibly.
